



## MAMIE MORRILL TUITION SCHOLARSHIP FUND

The Bethany Church family and Mamie's family and friends are offering a tuition scholarship in memory of Mamie Morrill who loved Bethany Church Of Wanchese Preschool very much.

They understand that the expense of preschool can be a strain on a family's budget. They would like this scholarship fund to help eligible families reduce their cost. This will give other children the opportunity to start their fun and learning at a great place where your faith and family life can grow strong.

Scholarships will be awarded based upon need and may provide between 25% - 100% of total tuition cost. This scholarship is for full year students. The family is responsible for providing the remaining tuition, due on the dates outlined in the preschool parent handbook. Applications are received by the preschool teacher who will then submit application to the preschool board for review. All personal financial documents provided during the application process will remain confidential and be returned or destroyed after scholarships are awarded.

The application review process will **begin June 1**. If you would like to apply, please submit the following:

- \*Scholarship application, with the supporting documentation required.
- \*Preschool registration forms. The \$20.00 registration fee is due with your paperwork.

The application can either be dropped off at the preschool to the teacher, Church office or mailed to:

The teacher will then notify all applicants by **July 1** of the preschool board's decision.
